

**FINCANTIERI TO BUILD “SILVER MUSE” FOR SILVERSEA CRUISES*****Revealed the client of the order acquired in 2014***

***Trieste, 1 July 2015*** – Fincantieri announces that the order for a new ultra-luxury cruise ship acquired in 1H 2014 is for the client Silversea Cruises. The unit will be named “Silver Muse” and is set for delivery in April 2017.

At 40,700 grt and accommodating 596 guests, the new ship will represent an evolution of “Silver Spirit” that will redefine ultra-luxury ocean travel, always maintaining the small-ship intimacy and spacious all-suite accommodations that are the hallmarks of the Silversea experience.

The addition of the newbuild will expand Silversea's fleet to nine ships, and will once again significantly raise the bar in the ultra-luxury cruise market with a wealth of enhancements to the onboard experience, while satisfying the uncompromising requirements for comfort, service, and quality of the world's most discerning travellers.

Headquartered in Trieste (Italy), the Group has approximately 21,900 employees, of whom around 7,700 in Italy, and 21 shipyards in 4 continents. In 2013 the Group acquired VARD, a company listed on the Singapore Stock Exchange that builds offshore support vessels for oil & gas exploration and production. Fincantieri is present in the UAE with Etihad Ship Building, a joint venture set up with Al Fattan Ship Industries and Melara Middle East, to design, produce and sell different types of civilian and military ships as well as perform maintenance and refitting activities.*
