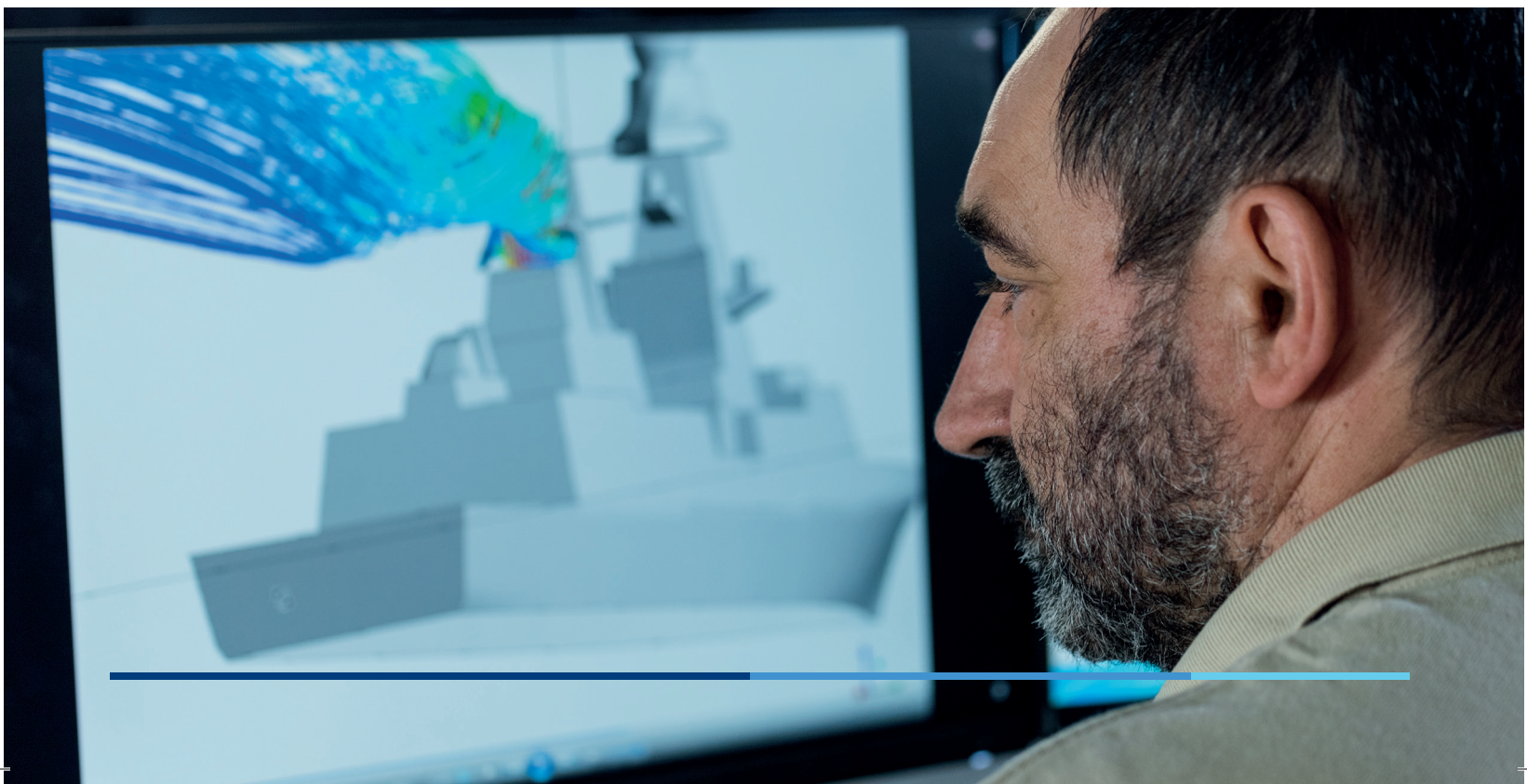
### ABOUT SEA 5000

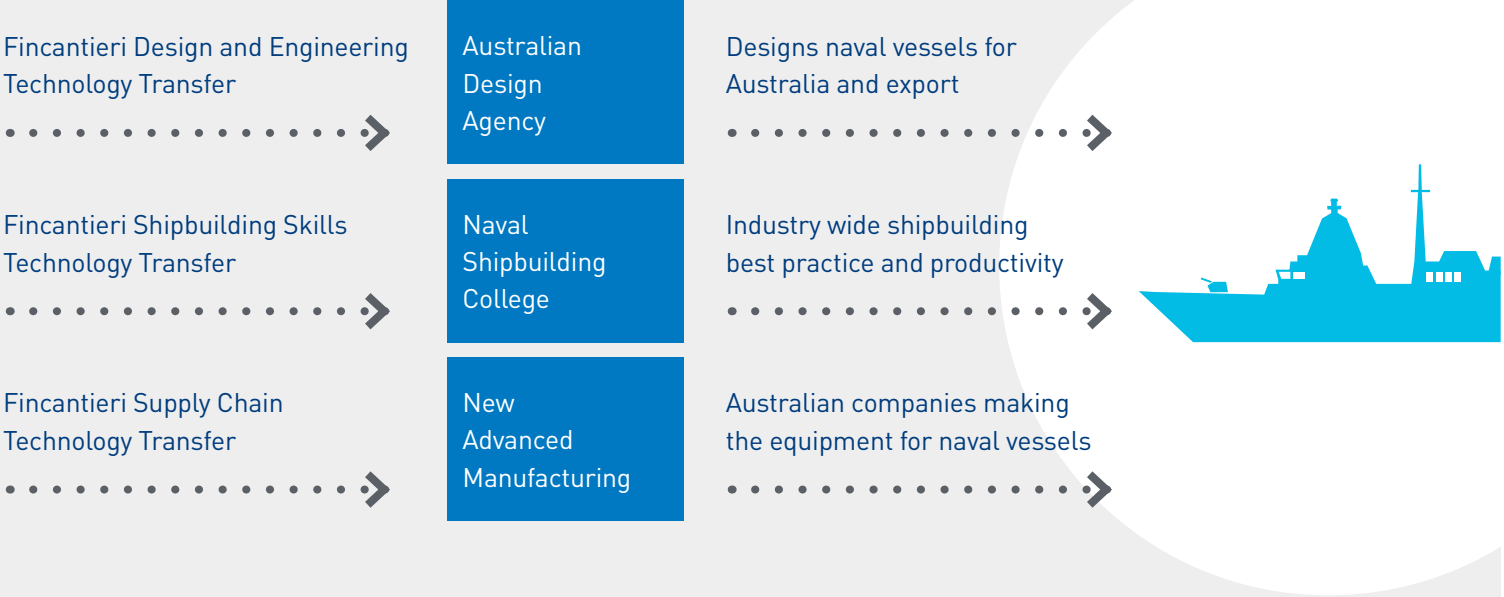
### A CONTINUOUS NAVAL SHIPBUILDING INDUSTRY FOR AUSTRALIA

Fincantieri's size and strength means we design and build naval vessels from the keel up including the mechanical equipment and state-of-the-art systems. Commencing in 2018, we propose to transfer the technology to Australian workers, management, institutions and businesses. By doing so, Australia will gain the knowledge, capability and independent control to design and build new naval vessels, and design and manufacture the advanced equipment and systems within them.
