## PRIVACY POLICY PURSUANT TO LEGISLATIVE DECREE NO. 196/2003

The data controller, FINCANTIERI S.p.A., will only process the personal data provided for the purposes referred to in this document, i.e., for attendance by the Proxy/Substitute for the Proxy at the ordinary and extraordinary shareholders meeting on 11 May 2018 to represent the party granting the proxy. The provision of personal data and the processing of the same are necessary for the aforementioned purposes. A failure to provide the aforementioned personal data will make it impossible for the Proxy/Substitute for the Proxy to attend the Shareholders Meeting as representative of the party granting the proxy.

The personal data will be processed for the purposes set out above mainly by automated means and using IT and telematic tools (designed to store, handle and send the said data), as well as by storage in paper form, in full compliance with the security measures imposed by Legislative Decree No. 196/2003 as well as the principles of necessity, relevance and propriety established by the data processing legislation.
