Since June 9, 2020 he has been Standing Auditor of FINCANTIERI S.p.A.

Born in Naples in 1964 and graduated in Business Economics in the academic year 1991/1992, after graduating from the state Grammar School at the "Vittorio Imbriani" in Pomigliano d'Arco, he is chartered accountant. Since 1999 he has been enrolled in the Register of Legal Auditors and in the Register of Chartered Accountants of Nola. Since 2003 he has been enrolled in the Register of Technical Consultants of the Court of Nola.

From 2003 to 2010, he was an auditor of joint stock companies. Since 2000 he has performed the role of bankruptcy trustee, judicial custodian of real estate, professional delegate for real estate sales and Technical Consultant at the Court of Nola.

Since 2019 he has been member of the Board of Statutory Auditors of Azienda Sanitaria Locale of Salerno and of the company Aeroporti di Roma S.p.A. From 2003 to 2010 he was standing member of the Board of Statutory Auditors of Enam S.p.A. and from 2003 to 2006 of Agenzia Metropolitana per la cultura S.p.A.

Since 2009 he has performed the role of judicial custodian and professional delegate in several real estate enforcement procedures at the Court of Nola. From 2000 to 2018 he served as bankruptcy trustee at the Court of Nola, managing several insolvency proceedings until closure, with liquidation of movable and immovable property, while performing the role of Technical Consultant at the same Court, providing accounting and banking appraisals. From 2005 to 2011 he was also judicial custodian of companies subject to seizure by the Court of Nola.

He has lectured both within the insolvency law course organized by the AIGA of Nola and the Order of Accountants of Nola, and within the course for delegated professionals organized by the Order of Accountants of Nola.

Since the beginning of his professional experience, he has attended several training courses, mainly on auditing, executive procedures, insolvency law and bankruptcy proceedings, as well as tax law.

From 1992 to 1999 he worked as an employee at Banco di Napoli. In particular, from 1992 to 1993 as employee in the Securities Office of the Parent Company Branch of Nola and from 1993 to 1994 as employee in the Loan Office. Subsequently, from 1994 to 1995 he worked at the Credit Recovery Office, in direct contact with customers and external legal consultants taking care of the different phases of recovery: elaboration of repayment plans, debt outflow monitoring, initiation of the most appropriate legal actions. From 1995 to 1999 he worked as an employee at the Credit Line Office, in direct contact with customers and with coordination functions of the other employees as well as interface for the positions of competence of the DG between the parent company branch of Nola and the Creditalia Central Service. From September to December 1999 he was manager of small businesses at a credit center consisting of 3 branches, covering the function of proposing body for credit lines, as well as of management of performing and non-performing credit relationships.
