DISCLOSURE ON PRIVACY PURSUANT TO LEGISLATIVE DECREE NO. 196/2003

The owner of the data processing, FINCANTIERI S.p.A., will process the personal data provided solely for the purposes necessary for the objectives indicated in this document and, in other words, for the attendance at the ordinary and extraordinary Shareholders' Meeting scheduled for 28 April 2015 by proxy. The grant of personal data and processing of the same are necessary for the above-mentioned purposes. The failure to provide the above-mentioned personal data would prevent the attendance at the above-mentioned Shareholders' Meeting by proxy.

The person in question may, furthermore, oppose the data processing in the circumstances and for the reasons indicated in above-mentioned Legislative Decree No. 196/2003
