The solution developed by Remazel will enable operations at depths of up to 400 meters and a production capacity of 2,000 tons/hour, ensuring precision, efficiency, and operational continuity even in complex marine conditions. The centralized control system will coordinate all onboard equipment, optimizing processes and enhancing overall operational safety.

This agreement marks a further step in Fincantieri Group's strategy to strengthen its presence in the underwater sector and consolidates the Group's position as a leading technological partner in the protection of offshore subsea infrastructure, an increasingly strategic area in the global geopolitical context.
