**ENVIRONMENTAL, HEALTH AND SAFETY POLICY**

**The Environment and Safety Policy of the Fincantieri Naval Vessels Business Unit** is consistent with the relevant Group policies.

## PRINCIPLES

The principles implemented by **the Fincantieri Naval Vessels Business Unit**, as a reference for the Environment and Security aspects concern:

- Compliance with existing environmental and safety provisions;
- the implementation of policies and guidelines for the implementation of environmental protection and safety established by the Group;
- Promoting employee participation in the process of risk prevention, environmental protection and the protection of health and safety against themselves, colleagues and third parties;
- Satisfaction with stakeholder expectations as a fundamental prerequisite for creating value and promoting sustainable development.

## COMMITMENTS

**Fincantieri SVP Naval Vessels Business Unit**, according to the Company Environmental, Health and Safety Policies and the site demands, commits to translating the principles into actions, continuing:

### 1) regarding the environment:

- replace the gases used in conditioning systems with types that will ensure less impact on climate change and global warming on the planet;
- to promote interventions to make employees' home-work shift more viable by raising awareness and encouraging the use of forms of collective mobility and low environmental impact;
- Improve the containment of noise levels of service facilities for the benefit of work environments and external environments.

### 2) regarding work health and safety:

- To carry out improvements and enhancements to lighting workstations, which also aim at optimizing consumption;
- integrate the facilities in the health care center and provide the training of the relevant staff;
- improve the interior design of the building in modernization logic to further reduce the risk and enhance its signaling.

## 3) as regards engineering:

- define design criteria for the environmental aspects of the ship's product through the collection and analysis of the relevant regulations and the assessment of any requirements for eco-sustainable design that emerge from the reference context;
- Ensure that the assumptions, principles and control metrics identified for the production of environmentally friendly products are translated into project choices and acquisition of ship / ship machinery.

## 4) for purchases:

- pursue the search for new suppliers able to propose products and technologies with ecological footprint;
- define requirements applicable to the supplier list in order to ensure the provision of sustainable products and services.

## REPORTING

- Periodic publication of results and performance indicators in the environment, health and safety;
- sharing analysis of environmental, health and safety accidents;
- Sharing, within the organizational structure of the Management, the findings that emerged during the audits.

All employees of the **Fincantieri Naval Vessels Business Unit**, and in particular the figures representing the environment, health and safety issues (primarily the Executives and the Quadrats for the relevant areas), have the task of monitoring and to periodically verify that the above principles and commitments are respected.
