FINCANTIERI

The **Fincantieri Riva Trigoso Shipyard Environmental, Health and Safety Policy** is coherent with the relevant Policies of Fincantieri Group.

PRINCIPLES

The principles implemented by **Fincantieri Riva Trigoso Shipyard**, as reference points for environmental, health and safety management, concern:

- the compliance with the environmental, health and safety legal requirements in force;
- the implementation of Fincantieri group policies and guidelines in the field of environmental protection, health and safety;
- the promotion of employee participation to the risk assessment and environmental, health and safety protection processes, for the benefit of their own, the colleagues and the third parties;
- the stakeholder expectation meeting, as fundamental requirement for the value creation and the sustainable development promotion.

COMMITMENTS

Fincantieri Riva Trigoso Shipyard, according to the Company Environmental, Health and Safety Policies and the site demands, commits to translating the principles into actions, continuing:

1) regarding the environment:

- to keep low energy consumption, through the implementation of leds lighting systems in areas where this kind of solution is not applied yet, and to progressively substitute machinery electric engines with high efficiency motors;
- to limit environmental sound emissions levels soundproofing productive areas and modernizing air extraction plants;
- to minimise risks of potential pollution through the installation of first rain water purification systems and through the addition of emergency drain blocking systems, in case of spillage;
- to communicate and promote, the use of sustainable transport modes for home-to-work shifts of those who access the Shipyard;

2) regarding work health and safety:

- to implement engagement activities, directed both to its employees and to the supply companies, in the field of environment and safety protection, as drafting information brochures related to workers health and promoting dedicated meetings for accident analysis;
- to renew and to improve obsolete equipment in order to improve their performance and to decrease risks of accidents;
- to improve infrastructure, workplaces and restrooms in order to make them more efficient, following the productive requirements and the current hygienical and sanitary standards;
- to enhance the management of internal emergencies also through the acquisition of a new ambulance to transport personnel who may need assistance.

REPORTING

- Periodic reporting of the environmental, health and safety performance indicators and results;
- Disclosure of the environment, health and safety related incident analysis;
- Sharing of audit results with the Shipyard organisational structure.

All the **Fincantieri Riva Trigoso Shipyard** employees, and in particular those who are responsible for environmental, health and safety surveillance (starting by Executives and Managers for their competences), have the task to watch over and verify that the above-mentioned principles and commitments were fulfilled.
